I agree that my volunteering services to Penny Lane Farm Sanctuary are performed on a volunteer basis without pay, without medical or worker's compensation insurance and without compensation of any kind. All of my volunteering services are performed at my own risk. I agree that it is my responsibility to act in such a manner as to be responsible for my own safety while volunteering.
4. I authorize Penny Lane Farm Sanctuary to contact the emergency contact provided and seek emergency medical care in cases of accident, illness or injury.
5. I have disclosed all relevant medical conditions in this application and will advise Penny Lane Farm Sanctuary of any changes. I agree that all medical care and medications are my own responsibility and I release Penny Lane Farm Sanctuary from all responsibility with respect to the same.
6. I acknowledge the risks and dangers inherent in handling, walking, grooming and feeding animals, working in a farm environment and in otherwise volunteering at Penny Lane Farm Sanctuary and I freely assume and fully accept these risks. I hereby waive any rights to a cause of action or future cause of action I may have against Penny Lane Farm Sanctuary and its Representatives, and release, discharge, indemnify and hold harmless Penny Lane Farm Sanctuary and its Representatives from and against all claims, actions, costs, expenses and demands, in respect to the following, not limited to death, injury, loss or damage to person or property, arising out of or in connection with my volunteering, howsoever caused, even if such loss or injury is caused by the negligence or default of Penny Lane Farm Sanctuary and its Representatives.
7. I agree to this waiver, indemnity and consent on behalf of myself, my heirs, executors and assigns.
